Peter Barkmann grew up on an *Acequia* in the Rio Grande Valley of Northern New Mexico. Naturally, irrigating alfalfa fields in a geologic rift adjacent to the stunning Jemez caldera lead to a keen interest in both geology and water resources. His career ah followed this interest spanning minerals exploration; petroleum development and exploration, geothermal exploration; and water resources investigation. For the past 25 years he has focused mainly on groundwater resources and environmental geology. Peter joined the Colorado Geological Survey in 2002 where he conducts regional water-resource investigations, environmental assessments, and manages the Ground Water resources program. He has also been fortunate to contribute to the geologic mapping efforts of the STATEMAP 1:24,000 Geologic mapping program.

Peter is author of the recent Colorado Geological Survey publication *Cross-sections of the fresh-water strata of the Denver Basin* and co-author for the *Bedrock Geologic Map of the Denver Basin*, *Artificial Recharge of Ground Water in Colorado-A Statewide Assessment*, as well as the award winning *Ground Water Atlas of Colorado*. He served Colorado Ground-Water Association as Vice President-President-Past President from 2001 through 2003.
